

A REPORT FROM ALICIA

Here is my First Quarter Report for the Staff Parish Relations Committee: We have been focusing on three key things:

<u>First</u>, our share in finding Pastor David's replacement. We created our "wish list" for Pat Simpson which we have turned over to her office. We will be fine tuning it when we meet with Pat in mid-April. At this point no other news on this front.

Second, we have been gathering information and working on updating all church job descriptions. This is still in progress. Some times our wants are not the practical answer to what the Church can support financially. We hope to have the descriptions completed soon but we shifted our focus slightly upon learning that Connie would be leaving after Palm Sunday.

Our third focus became our priority. We began working on updating the Choir Director/
Accompanist job descriptions. We did this in conjunction with developing a plan to hire a musician for the Church. Thanks to Carlene Campbell, a former musician for the Church, we found Laura Frank. Laura is a student at SPU and will be graduating in June. Laura will join us Easter morning for the 10:30 service as our musician. She will be with us at least through the end of June. Please help us welcome Laura to our Church.

FINANCES

Under the leadership of Janelle Woolsey, Coordinator, a review of our financial records is nearly finished. Suggestions are being prepared regarding a more effective placement of balances on hand.

Stephanie Hansen, our treasurer reports that our income in February was \$8,701.87; our expenses in February \$9,741.16.

Income Y-T-D was \$20,622.66; Expenses Y_T-D, \$18,493.12.

We have paid our yearly Fire and Lability Insurance Premium of \$2329.00.

The 2010 Property Tax bills have been received. Our taxes on all church properties will be \$8627.97. This will be paid in two payments in April and October. 2010 Property Taxes are about \$300 less than 2009.

2009 wages were reported to the government and all employees received their w-2 forms.

All donors should have received a summary of their contributions in 2009 for their tax purposes.



A NEW INTERIM MUSICIAN!


